

Explore and Interact with Your Museum's 2024 Paranormal Experience

Learn the skills to find out if the Trails & Rails Museum has ghosts roaming around and explore the "living(?) history" in its buildings.

Ghost Hunts include approximately an hour training session, which includes hints and tips taught by Ghost Hunters Scotty O. and Jacob Sikes, approximately 3 hours of ghost hunting in the authentic Buffalo County buildings, and a wrap-up session to discuss evidence captured that evening.
